



Parent or legal guardian Player Waiver and Release of Liability for NFL Flag Vancouver

To participate in the NFL FLAG VANCOUVER program (organized by Right Choice Athletics and Training Society)(RCATS), I hereby agree to the following:

- I release and waive any claims against the NFL FLAG VANCOUVER League, their employees, sponsors, agents, and affiliates for any personal injury, property damage, or wrongful death that may arise as a result of the Participant's participation in the Program, caused by the ordinary negligence of the parties listed above, wherever, whenever, or however, the same may occur.
- I acknowledge that those listed above are not responsible for any injury or property damage arising from the Program, even if caused by their ordinary negligence.
- I certify that the Participant is in excellent physical health and may participate in strenuous and hazardous physical activities, including football played in the Program.
- I understand that this agreement is intended to be as broad and inclusive as permitted by the laws of the province in which the program takes place. If any portion of this Agreement is invalid, the remainder will continue in full legal force and effect.
- As the parent or legal guardian of the Participant, I am of legal age and freely sign this Agreement. I have read and understood this form, and I acknowledge that by signing it, I am giving up legal rights and remedies. I As Guardian or parent I understand and agree that RCATS and its directors, officers, employees, agents, and volunteers shall not be liable for any direct, indirect, incidental, special, or consequential damages arising from or in any way related to my participation in NFL Flag Vancouver, even if RCATS has been advised of the possibility of such damages.
- In no event shall the total liability of RCATS and its directors, officers, employees, agents, and volunteers exceed the amount of the registration fee paid by me for participation in NFL Flag Vancouver.

Refund Policy:

NFL Flag Football offers refunds according to the following timelines. To request a refund, please email your League Operator.

- Full or 100% registration fee refund if requested before uniforms are ordered for the league, which occurs 4 weeks prior to the league start date (JUNE 4, 2023). Please note that banking and service fees are non-refundable.
- 50% registration fee refund if you request it after uniforms are ordered and before the 1st game of the season. Please note that banking and service fees are non-refundable.
- No refunds will be processed if you submit a request after the first game of the season.

- All exchanged jerseys must be NEW in the original packaging. There is a \$25 exchange fee to cover restocking, processing, and return shipping. Limit of one exchange per season. Exchange orders will be shipped via FedEx ground only.
- NFL FLAG does not issue refunds on equipment. Please make sure you double check your order prior to submitting online. Exchanges ONLY
